

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.theamesite.com](http://www.theamesite.com), and AME Solutions, LLC and governs data collection and usage. ## Collection of your Personal Information

In order to better provide you with products and services offered, AME Solutions may collect personally identifiable information, such as your:
